MEMBERSHIP FEES

- Membership fees are charged at either a full year's membership rate, or if the new member applies after December 31 a half-year's rate.
 - Full year membership (1 July to 30 June) \$110 inc GST
 - Half year membership (1 January to 30 June) \$55 inc GST.
- Membership fees, in total or in part, are not refundable.

MEETINGS OF THE COMMITTEE OF MANAGEMENT

- Committee meetings are held at 7:30 pm on the third Wednesday of each month.
- Committee meetings are to be open meetings. All members of the Association, or their representatives, and non-members are able to attend the monthly committee meeting.
- Non-committee members may be asked to leave the committee meeting if “in confidence” items are to be discussed.

VOTING METHOD AT GENERAL MEETINGS

- Voting for an item where there are more than two options will be by the “first-past-the-post” method. That is, the options gaining the most votes will be selected.
- In the case of a tie the Chairperson may exercise his or her right to make a second vote.
- All interested parties may appoint scrutineers for the vote counting.
- The winners of the vote must be announced and the number of votes each received must be recorded.

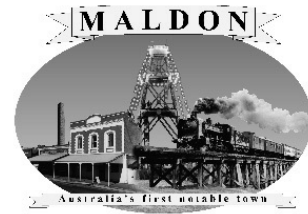
